Perstorp's head offices are located in Malmö, Sweden and Perstorp is engaged through its subsidiaries in the production of chemicals and biofuels in Sweden, the United Kingdom, the United States, China, Italy, Germany and the Netherlands.

Our supply chain includes suppliers of goods, work and services which are required for our operations and as input material to the products we produce. Suppliers are in general contracted centrally, but each site also has local suppliers for some supplies of goods and services.

Our business and success rely on the trust and confidence from our stakeholders. Modern slavery in all its forms including servitude, forced labor and compulsive labor and human trafficking is completely unacceptable. We as a Group are committed to prevent any occurrences of modern slavery, in any of our own businesses and in our supply chain. We operate according to our Code of Conduct which is based on our cultural core values of reliability, responsibility and focused innovation. Our values are close to our hearts and we request from our suppliers and business partners that they conduct their business in a lawful and ethical manner. This includes preventing or eliminating modern slavery in all its forms. All our employees are required to read and acknowledge our Code of Conduct.

Our suppliers of large spend, and those considered of high risk in terms of their geographical presence, are assessed in our supplier evaluation system. They are then also required to acknowledge our Vendor Policy, which includes requirements related to amongst others, forced labor and child labor.

Our Vendor Policy also requires of suppliers to assure that they are working to ensure that Perstorp's production and products are free of conflict minerals originating from the Democratic Republic of Congo or adjoining countries in accordance with the US Securities Exchange Commission Rule of Conflict Minerals issued on August 22, 2012 and any updates thereof.

We have not identified any occurrences of modern slavery or human trafficking in our own businesses or in our supply chain during 2017. To further mitigate any risks of such occurrences we will intensify our focus on the suppliers' compliance with our policies, through more specific social audits in the coming years.
